#### **RECOMMENDATION:**

That Council approve application DA0328/2000 to construct a boiler and boiler room (level 2 activity) at 110 Lindsay Street subject to the following conditions:

#### **ENVIRONMENTAL CONDITIONS**

#### General

- A copy of the requirements of this permit and any associated documents referred to in this permit must always be held in a location that is known and accessible to the person responsible for the activity. All persons who, at any time, may be responsible for the activity carried out on the land, including contractors and sub contractors, must be familiar with the requirements of this permit as may be relevant to their work.
- G2 Subject to the requirements of the relevant planning scheme, none of the following changes may take place in relation to the activity authorised by this permit without a new permit from the relevant planning authority where the authority determines that a permit is required or, if no such permit is required, the prior written approval of the Director:
  - (a) a change to a process used in the course of carrying out the activity; or
  - (b) the construction, installation, alteration or removal of any structure or equipment used (or previously used) in the course of carrying out the activity; or
  - (c) a change in the nature of materials dealt with or used in the course of carrying out the activity;

which may cause or increase the emission of a pollutant, or otherwise result in environmental harm.

**G3** Notification of incidents:

- (a) If an incident causing or threatening serious or material environmental harm from pollution occurs in the course of the activity to which this document relates, then the person responsible for the activity must:
  - (i) immediately take all practicable action to minimise any adverse environmental effects from the incident; and
  - (ii) as soon as reasonably practicable, but not later than 24 hours, after becoming aware of the incident, notify the Director of the incident by a telephone call to the 24-hour emergency telephone number 1800 005 171: and
  - (iii) not later than 24 hours after becoming aware of the incident, provide a written report to the Director by facsimile to (03) 6233 3800, or by hand delivery, outlining the nature of the incident, the circumstances in which it occurred and the action taken to deal with the incident (this report must be provided irrespective of whether the person responsible for the activity has reasonable grounds for believing that the incident has already come to the notice of the Director or any officer in the administration or enforcement of the EMPCA).
- (b) Any notification given by a person in compliance with this condition will not be used in evidence against the person in proceedings for an offence or for the imposition of a penalty (other than proceedings in respect of the making of a false or misleading statement).
- **G4** If the person who is or was responsible for the activity ceases to be responsible for the activity, then, within 30 days after that cessation, that person must:
  - (a) notify the Director in writing of that fact;
  - (b) provide the Director with full particulars in writing of any person succeeding him or her as the person responsible; and
  - (c) notify any such persons of the requirements of the permit and any additional permit or environment protection notice amending the permit and that it is binding on him or her.
- If the person responsible for the activity is not the owner of the land upon which the activity is carried out and the owner of the land changes, then within 30 days after becoming aware of the change, the person responsible must notify the Director in writing of the change of ownership.

G6 The woodwaste feedstock (dry planings and shavings) for the 10MW boiler must have a moisture content not greater than 20% (dry basis).

#### **Atmospheric**

- A1 Stack testing facilities must be provided and maintained on the exhaust stack serving the wood-fired boiler. Sample ports must be located in accordance with Australian Standard AS4323.1-1995 'Stationary source emissions Selection of sampling positions' or as approved in writing by the Director and must be suitable for any test method specified by the Director.
- A2 A device must be installed and maintained to continuously record the percent obscuration of gases within the exhaust stack serving the 10MW wood fired boiler. An alarm that alerts the operator when the percentage obscuration exceeds 40 percent must also be installed and maintained. The percentage obscuration records must be retained for a minimum of two years and must be made available to any authorised officer upon request.

The obscuration-measuring device must be maintained and calibrated regularly in accordance with the manufacturer's instructions. Maintenance and calibration records for this device must be retained and made available to any authorised officer upon request.

- **A3** (a) The emission from the wood fired boiler must not appear darker than shade 2 on the Ringelmann Chart.
  - (b) Sub-condition (a) of this condition does not apply during one period of not more than 20 minutes in any period of 24 hours during which the emission appears darker than shade 2 on the Ringelmann Chart but not darker than shade 3 on the Ringelmann Chart if:
    - the reason for the emission appearing darker than shade 2 on the Ringelmann Chart during that period was solely due to lighting up; and
    - (ii) all practicable means were employed to prevent the emission appearing darker that shade 2 on the Ringelmann Chart during that period.

- A4 The woodwaste (dry shavings and planings) collection, transfer and storage system must be designed and maintained so that fugitive dust emissions are effectively controlled. This requirement shall be considered breached if dust from the sawdust collection system is visible crossing the boundary of the land, or it can be shown a collection efficiency of 98% for all particles over 50  $\mu$ m in diameter is not being achieved.
- A5 (a) During the commissioning phase, every practical step must be taken to minimise the emission rate of  $NO_x$  (i.e.  $NO + NO_2$ , as  $NO_2$  equivalent) emitted from the wood-fired boiler without concomitant increases in particle emissions.
  - (b) On determination of the conditions required for mimimum  $NO_x$  generation, all practical steps must be taken to ensure the boiler is configured to operate according to these conditions without compromising particle emissions.
- A6 For the initial two years of boiler operation (after commissioning) air emissions from the 10MW wood-fired boiler must be monitored on a six-monthly basis, in accordance with the following requirements:
  - (a) The following tests must be conducted:
    - (i) gas velocity and volume flow rate;
    - (ii) exit gas temperature;
    - (iii) water vapour concentration;
    - (iv) mass rate and concentration of total particulates and  $NO_x$  (as  $NO_2$  equivalent); and
    - (v) percentage oxygen and percentage carbon dioxide during the sampling event.
  - (b) Samples must be representative of the air emission when the activity is operating under normal conditions.
  - (c) Reporting of these measurements to the Director must be made by no later than 30 days from receipt of results. The report must include:
    - (i) the date of measurements;
    - (ii) weather information at the time the measurements were taken;
    - (iii) operating conditions at the plant, during the time in which the measurements were taken;

- (iv) the method employed to produce the measurements; and
- (v) comment and discussion on the data provided.
- (d) In addition to the items specified in (d), the monitoring report must also include graphical representation of percentage obscuration (either sixmonthly or annualised), using hourly averages from the obscuration device or an alternative method acceptable to the Director.
- (e) From the third year of boiler operation an annual monitoring program of air emissions from the boiler must be conducted, in accordance with requirements (a) (d).
- A7 (a) From the date of commissioning until 31 December 2004 the maximum concentration of substances emitted from the boiler stack must not exceed the concentration values listed in Table 1 of this permit.
  - (b) After 31 December 2004, the maximum concentration of substances emitted from the boiler stack must not exceed the concentration values listed in Table 2 of this permit.
- (a) Ground-level concentrations of particulates and NO<sub>x</sub> (as NO<sub>2</sub> equivalent) must be re-calculated after commissioning and compared with modelled ground-level concentrations to assess the actual emission impact of boiler operations. Measurements should be performed over the operating range of the boiler, not only at maximum capacity.
  - (b) The results from measurements obtained in (a) must be submitted to the Director within 30 days of completion of the emission assessment program.

#### **Solid Waste**

- **S1** Unless otherwise approved in writing by the Director:
  - (a) All boiler ash/ fly ash from the combustion process must be removed at regular intervals and re-used for beneficial purposes or removed for disposal in a manner approved by the Director.
  - (b) Intermediate storage of bottom ash/ fly ash must be undertaken in closed containers or in a closed storage space intended for this purpose.

**S2** No wood or woodwastes, including planings, shavings and dockings must be burned on-site, other than in the 10MW wood-fired boiler.

#### **Waste Water**

W1 Boiler blow down/ wash down water from the 10MW wood-fired boiler must be directed to the Launceston City Council sewer and must comply with all conditions attached to any Trade Waste Agreement ratified between the person responsible for the activity and the Council.

#### Monitoring

- Any sample(s) that must be obtained by the requirements of this notice must be subject to the following:
  - (a) each sample must be tested by
    - (i) a government laboratory and/or
    - (ii) (A) a laboratory registered with the National Association of Testing Authorities (NATA) and/or
      - (B) a laboratory approved in writing by the Director for the tests and analyses specified for that sample in the requirements of this notice:
  - (b) Any sample(s) must be collected and analysed in accordance with the relevant Australian Standards, Codes of Practice or any other method approved in writing by the Director.
- M2 Monitoring and reporting programs for air emissions must be carried out in accordance with this permit and the monitoring and reporting requirements given in Schedule 3.

#### **Noise**

N1 Within thirty days of commissioning of the 10MW wood-fired boiler, a noise survey must be conducted to assess noise levels, under normal operating conditions, at the boundary of the land and at the boundary of the nearest domestic premises in other ownership. A report containing the noise survey results, along with any noise mitigation strategies, must be submitted within 30 days of the completion of the survey.

#### **DEVELOPMENT CONDITIONS**

- **D1** The use and development shall be generally in accordance with the endorsed plans.
- Stormwater drainage from the proposed development is to remain separate from the internal sewerage system and is to connect to an existing dedicated stormwater connection or open drain within the site. Consideration should be given to further separate any adjacent stormwater connections discharging to the sewer as part of the works as this may negate any future requirement to do so. All drainage works are to be to the satisfaction of Councils Plumbing Inspector.
- Provision shall be made for the disposal trade waste and the collection of oil and other waste products to the satisfaction of the Councils Plumbing Inspector.
- **D4** Prior to the commencement of construction of this development a trade waste permit must be obtained.

#### **DEFINITIONS**

Definitions of terms used in the environmental conditions of this permit are contained in Schedule 1 of this permit.

#### **ENVIRONMENTAL CONDITIONS**

The person responsible for the activity must comply with the above conditions and those contained in Schedule 3 of this permit.

#### Schedule 1

#### **DEFINITIONS OF TERMS**

used in the environmental conditions of this permit. For the purposes of this permit:

'Activity' means one or more environmentally relevant activity or activities (as defined in section 3 of the EMPCA) to which this notice relates.

'Best Practice Environmental Management' or 'BPEM' has the meaning described in section 4 of EMPCA.

'EMPCA' is the Environmental Management and Pollution Control Act 1994.

'Environmental nuisance' has the meaning described in Section 3 of the EMPCA.

'Environmental harm', 'material environmental harm' and 'serious environmental harm' each have the meanings described for them in Section 5 of the EMPCA.

'person responsible for the activity' is any person who is or was responsible for the environmentally relevant activity (or activities) for which this permit is issued and includes the officers, employees, agents and assigns of that person.

'Planning authority' means a municipality (Council).

'The Director' is the Director of Environmental Management appointed under section 18 of the EMPCA. The Director is located within the Department of Primary Industries, Water and Environment.

'The land' means the land where the activity to which this permit relates may be carried out (refer Attachment 1). For the purposes of this permit the land is defined as the parcel of land in CT 46346 folio 1, Lindsay Street, Launceston and includes:

- (a) buildings and other structures permanently fixed to the land; and
- (b) land covered with water: and
- (c) water covering land; and

any estate, interest, easement, servitude, privilege or right in or over land as defined in the Land Use Planning Approvals Act 1993.

- A. Prior to commencement of this development and use, the following are required:
  - a) Building permit
  - b) Plumbing permit
- B. This permit lapses after a period of two years from the date of granting of this permit if the use or development has not substantially commenced within that period.
