- 4.1 Deputation Bass Strait Visitor Access Study

Mr Roberts gave a report to Council on the findings of the Bass Strait Visitor Access Study, some points made in the report included:

- Growth and profitability of the Tasmanian Tourism industry is directly linked to the access across Bass Strait.

- 4.1 Deputation Bass Strait Visitor Access Study...(Cont'd)
 - Events of the last three months have seen an increase in people spending their holidays within Australia and this has provided a good opportunity for Tasmania.
 - Tourism 21 The Tourism Industry and State Government Strategic Business Plan sets out broad strategies for the benefit of the tourism industry in Tasmania. For these strategies to work it is important that Tasmania has adequate access across Bass Strait.

Some of the major findings of the Bass Strait Visitor Access Study were:

- Travel to Tasmania is different to all other states as Tasmania is only accessible by sea or air, there is no possibility of road or rail transport.
- Tasmania is vulnerable to disruptions in access, as has been demonstrated when air and sea services have been cancelled or cut back for a number of reasons.
- There is unsatisfied demand for visitor travel across Bass Strait. (Particularly being able to travel with a car.)
- 80% of Australian want to use their car when going on holiday.
- Sea and Air travel cater for separate markets and there is no substitution available between the two.
- Most people travelling by sea bring a car, those travelling without a car prefer to travel by air.

Mr Cooper reiterated some points made by Mr Roberts and added that the report was fair and accurate in its findings.

The deputation answered the question of Council.

To consider an application for the installation of a projecting wall sign and the enlargement of the painted wall signs approved by DA0445/99.

PREVIOUS COUNCIL CONSIDERATION:

Council has previously permitted signage on the site (DA0445/99). This allowed two signs measuring 8m x 1.5m in two locations on the south facing wall. One permitted on the western end of the wall and one towards the middle of the boundary. One sign of 1.5m² was permitted on the western end of the north facing wall and one sign measuring 8m x 1.5m towards the middle of the wall fronting Lindsay Street.

RECOMMENDATION:

 - A sign with dimensions of 1.5m in width and 1.5m in height on the north b) facing wall.
 - That part of the wall not covered by advertising signs is to be painted C) grey to match the wall running along the southern boundary of the site.

Once endorsed, these plans shall supersede the original endorsed plans.

Such exemption may be granted subsequent to approval of a written application from a person or organisation outlining the reason(s) for consumption of liquor on public land within the City. This power of delegation may be on delegated from the General Manager to an appropriate officer(s).
