- The Co-pilots program must be seen within the broader context of a number of programs operating in the Esk Education district and around the State.

### 4.1 Deputation - Co-Pilots Mentoring Program...(Cont'd)

- Co-pilots is aimed at young people who are regularly absent from school and provides mentors to work with young people in an area of mutual interest. The program aims to demonstrate the benefits of the various education options available in Tasmania.
- Young people work with a mentor for a minimum of 18 hours over 6 weeks on an activity of mutual interest. This can be done at anytime convenient to both people.
- The program has 7 stages:
  - (1) June to mid-July The mentors are introduced to the program.
  - (2) Mid-July to Mid-August The mentors receive training.
  - (3) Mid-August to September The mentors and participants meet socially in order to find other people to work with as partners.
  - (4) October to November Activities begin, the activities are joint choices between the mentor and the participating young person.
  - (5) December Recognition of Achievement, certificates are awarded for the work done by participants and mentors. The recognition of achievement is a major part of the program.
  - (6) December Evaluation what the participants have gained from being part of the program and evaluation of the participants future involvement in education programs.
  - (7) December to 2002 Evaluation of the program.

4.2 Deputation - Safe Haven Outreach Inc - Youth Factory and Food Bank...(Cont'd)

- The Safe Haven Outreach Inc is a "Registered Gift Recipient Charity" and a "Income Tax Exempt Charity".
- The organisation has two projects which aim to assist street and homeless youth by providing work opportunities and a chance to build self esteem.
- The projects are a Youth Factory and Food bank.
- The Youth Factory will be an automotive repair shop which will repair cars damaged by young offenders and also repair and sell donated cars.
- It is planned to list the facility as a court appointed, work order registered area. This will enable young offenders convicted of committing an unlawful activity involving motor vehicles to help repair cars damaged during unlawful activities.
- The Food Bank will receive food from retailers when that food is part of a consignment that is written off, while still meeting health rules. The labels of this food will be written over with the Safe Haven label.
- Currently it is planned that when a young street or homeless person comes to the facility they will do 10 hours community work and will receive \$200 worth of food.
- The food bank plans to sell food goods to other charity organisations so they can distribute it to those in need.

The deputation answered the questions of Council.

# 8.2 1/35-43 Cypress Street - Conversion of Cypress Street Indoor Cricket Centre To Warehouse

**FILE NO:** DA0279/2001

#### **DECISION STATEMENT:**

To consider an application to convert the existing indoor sport centre to a warehouse.

#### PREVIOUS COUNCIL CONSIDERATION:

#### RECOMMENDATION:

That council approve DA0279/2001 to convert the existing indoor cricket centre to a warehouse subject to the following conditions.

#### **ENDORSED PLANS**

1. The use and/or development as shown on the endorsed plans must not be altered without the written consent of the Manager Approvals.

#### 2. RETAIL SALES

The premises is not to be used for the display or sale of goods to the public. The use is restricted to distribution of merchandise and trade sales only being made from the premises. No retail sales are permissible from this site at any time.

#### 3. HOURS OF OPERATION

The use may only operate between the hours of 8.00am to 5.30pm Monday to Friday and between 8.00am and 1.00pm on Saturdays.

#### 4. AMENDED PLANS REQUIRED

Before the use and or development commences, the areas coloured red in the endorsed plans shall be amended to show construction of fencing or barriers to prevent all vehicular access from Cypress Street to the subject land. The amended plans must be drawn to scale with dimensions and four copies must be provided. When approved by the Approvals Manager the plans will be endorsed and will then form part of the permit and shall supersede the original endorsed plans.

#### 5. MINOR WORKS IN ROAD RESERVE

The developer is to have the approved and associated minor works in the road reserve, as shown on the endorsed plan, constructed by suitably qualified persons to comply with current Council standard drawings (Series 7600) and completed to the satisfaction of the Infrastructure Assets Manager. Inspections are to be arranged with Council's Infrastructure Assets Division prior to the commencement of the public works, following preparation of the base (prior to concreting, paving or asphalt sealing) and at the completion of the works. A fee of \$50 for the inspection of minor public works is payable prior to the development commencing.

The public works are to include:

- a) Existing crossovers not used shall be removed and replaced with new kerbing to match the existing design along the street frontage.
- b) Existing driveways within the road reserve not used shall be removed and the area reinstated to match the adjacent areas.
- c) The works within the road reserve are limited to a maximum period of five days to avoid unnecessary disruption to pedestrian traffic.

#### PREVIOUS COUNCIL CONSIDERATION:

#### RECOMMENDATION:

That application DA0201/2001 to construct alterations to the existing hotel including carparking, access, a wall along part of frontage, coach area and internally illuminated pole sign at 17-33 Cameron Street be approved subject to the following conditions:

#### 1. ENDORSED PLANS

The use and/or development as shown on the endorsed plans must not be altered without the written consent of the Manager Approvals.

### 2. AMENDED PLANS REQUIRED (major amendments only)

Before the use and or development commences, the areas coloured red in the endorsed plans shall be amended to show the requirements mentioned below. When approved by the Manager Approvals the plans will be endorsed and will then form part of the permit. The amended plans must be drawn to scale with dimensions and four copies must be provided.

- a) The relocation of the proposed fence to provide a footpath alongside of the exit lane to the car park.
- b) The kerb radii of the exit lane to coincide with the swept path of a design motor vehicle.
- c) The boom gate island being moved south to clear the reversing path of a single unit vehicle using the southernmost bus parking bay.
- d) The sign is not to exceed 7.0 metres in height.
- e) The sign is not to exceed 2.5 metres in width.

Once endorsed, these plans shall supersede the original endorsed plans.

#### 3. PROTECTION OF PIPELINES

Construction over all Council pipelines is to be in accordance with the document "Guidelines for Design of Building Over or Near Pipelines" available from the Launceston City Council Technical Services Division. The existing underground sewer is to be located prior to the start of construction and all necessary steps taken to protect the pipe from damage during the construction process, including vehicular access over the sewer, or from loads transmitted to the sewer from the proposed buildings.

#### 4. CAR PARKING

Before the use commences, areas set aside for parking vehicles and access lanes as shown on the endorsed plans must be:

- a) Properly constructed to such levels that they can be used in accordance with the plans.
- b) Surfaced with an all-weather sealcoat.
- c) Drained to Councils requirements.
- d) Linemarked to indicate each car space and access lanes.

Parking areas and access lanes must be kept available for these purposes at all times.

#### 5. CAR PARKING USERS

Unless specified elsewhere in this permit, all parking spaces provided in association with a business, professional or commercial use shall be:

- a) Made available to the customers or clients of such use.
- b) Not restricted to the proprietors or employees.
- c) Made available only during the hours of operation.

#### 6. DIRECTIONAL SIGN

A discreet directional sign of not more than 0.3m2 may be provided at the entrance to the site indicating the availability of off-street visitor parking.

#### 7. ON-STREET EMPLOYEE CAR PARKING

No vehicle under the control of the operators of this use, or their staff, shall be permitted to park in the streets directly adjoining the subject site.

#### 8. PAINT FINISH

All external surfaces (including the underside of the coach bay) shall be of a pretreated nonreflective colour finish, or painted in muted colours to a good trade standard.

#### 9. FENCES

#### 11. MINOR WORKS IN ROAD RESERVE

The developer is to have the approved and associated minor works in the road reserve, as shown on the endorsed plan, constructed by suitably qualified persons to comply with current Council standard drawings (Series 7600) and completed to the satisfaction of the Infrastructure Assets Manager. Inspections are to be arranged with Council's Infrastructure Assets Division prior to the commencement of the public works, following preparation of the base (prior to concreting, paving or asphalt sealing) and at the completion of the works. A fee of \$50 for the inspection of minor public works is payable prior to the development commencing.
